Teache	Staff are doing well even with the loss of Ms. Aliverti over the summer The group discussed possible ways to honor Ms. Aliverti's enormous contributions to the school. Unfortunately, District policy does not allow for renaming the library in her honor. The idea of creating a free Little Library outside the school was also discussed, but the group noted there may be District limitations on that as well. Finally, soliciting donations for a reading based charity was discussed. The school's enrollment was discussed. 480 students was the projection at the end of the school year, but actual students now is 445. Bryant lost a full classroom of kids, mostly to Decatur with the District change to not sunset HCC. Bryant had one teacher eliminated in spring. Could have another position eliminated in October but have been tentatively told will not lose staff because fact that sudden loss of students was due to HCC decision by the District. -	There was an issue with the website recently which highlighted the need to move to new platform. Matt is exploring a move to Square Space. No additional cost is expected Islandwood fundraising had an overage from last year. That class would like to transfer the money directly to the current 5th grade class and maintain the PTSA grant at \$6K as budgeted. Another option is to include that transfer of funds in the income for this year and use it to offset the Islandwood PTSA grant. transferred directly to the PTSA or a restricted account, no further approval or vote is needed. Marika and Matt will discuss with the Islandwood parent leads (Mo Bhak) and report back on recommendation of how they would like to handle this.

- Chess Club is now part of ASE and is no longer being run as a club. This means that will need parent volunteers if want to still hold a chess tournament. This is a large fundraiser and could be used to fundraise for the PTSA (instead of chess club restricted account) if we would like to support the event. Chess Club also have money in their restricted account that could be used to hire someone to handle the technical aspect of the event. Marika will follow up with ASE chess lead to discuss approach.

Principal Update

- Staff and students are doing well after the sudden loss of Ms. Aliverti. School is working with Ms. Aliverti's family to organize a memorial that will be open to community. Targeting a date in Oct/Nov.

Bryant lost multi lingual and SPED headcount in budget but numbers were higher than expected. Have been awarded a emergency SPED assistant until new budget comes out. Expect restoration of real position with final budget

- Have hired a new librarian but will only be at .5 time (as opposed to .7). Students will still have library once a week. Will need to leverage community support to continue things like Global Reading challenge. Char would like to repurpose the additional .2 headcount for lunch room support.
- Highly Capable materials have been purchased for the school.
- 5th grade classrooms are very large. Board asks if there is anything we can do to support those teachers, such as funding extra classroom support. Dr. Marshall says no and notes that the PE teachers Mr. D and Mr. B will be pushing into those classrooms to support math differentiation.

Treasury Update

- Budget approved at the end of last year has remained unchanged. But we have adjusted income upward. There was \$59K in unspent funds in 2024-2025 that can carry over to this year. Unspent funds were primarily for field trips, IXL and staffing grant.
- One of our B of A accounts was hacked. This was not an active account. It was the account where we connected to Giving Fuel. No money was taken and account is frozen. Will need to reset all connections to Giving Fuel and are switching to a different payment processor that is easier to use as part of this work. There is no difference in cost in payment processors.

Annual Campaign and Fundraising Summary
